

# The Pennsylvania Sustainable Energy Finance Program (PennSEF): What is it?


PennSEF is a program that pairs sophisticated technical, legal, and procurement support with access to low-cost financing to assist universities and colleges (including twoyear institutions) in developing and implementing clean energy/energy efficiency measures that are guaranteed to pay for themselves. ### Infrastructure-scale Financing that Guarantees Savings Significant Net Savings from Beginning to End





# PennSEF Project Steps

At a glance

#### **START**

- Sign Letter of Interest (LOI) with PennSEF
- Discuss initial project ideas with PennSEF expert
- PennSEF helps your team prepare an RFP

### REQUEST PROPOSALS

- Review PennSEF
  template RFP
- Discuss PennSEF template Guaranteed Savings Agreement (GSA)
- Send RFP to PennSEF'sPre-Qualified ESCOs

### ESCO SELECTION

- Review PennSEF's template Cost and Savings Estimate (CSE) and learn its importance
- Ask pre-qualified ESCOs who respond to the RFP to submit CSEs
- Go over CSEs with PennSEF expert
- Select ESCO to begin work

### NO-COST PRELIMINARY AUDIT

- ESCO conducts preliminary audit at no cost to you
- Decide whether to request ESCO to submit GSA based on PennSEF template
- Assisted by PennSEF team, negotiate a GSA, and a monitoring and verification (M&V) plan



### FINALIZE GSA & IGA

- PennSEF's team works with you and the ESCO on an Investment Grade Audit (IGA)
- The IGA must guarantee energy savings whose value is equal to or greater than the project investment (including financing and fees)
- PennSEF team conducts independent review of costs and savings in the IGA regarding their reasonableness
- If you are satisfied with the GSA and IGA, both documents are prepared for signature
- PennSEF team develops a Financing Plan, or you may use your own financing


